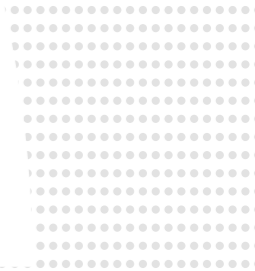
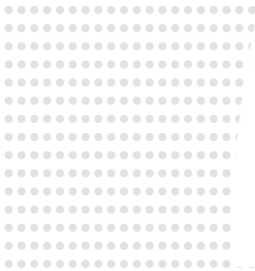

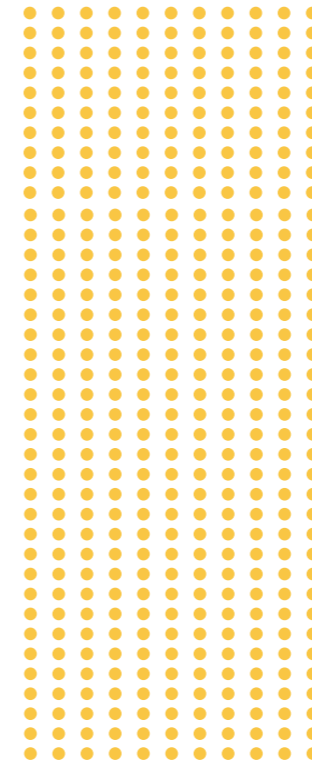
# About Us
